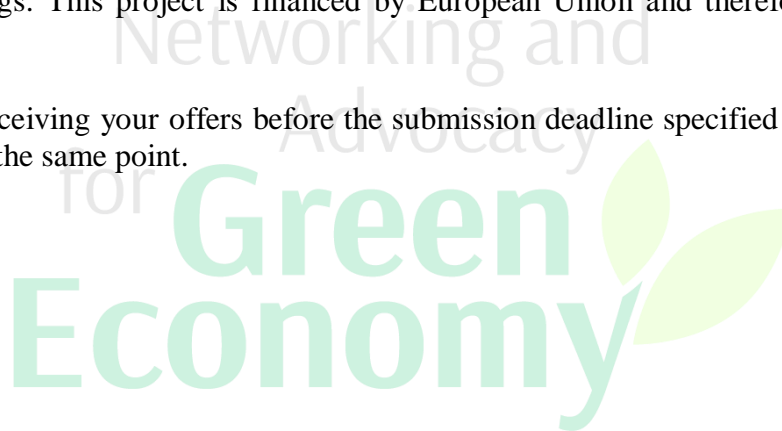
In accordance with the project Work plan, it is envisioned to organize second national training on 10,11,12 March 2019.

7.2 It will be checked also whether the proposed price is within the available budget.

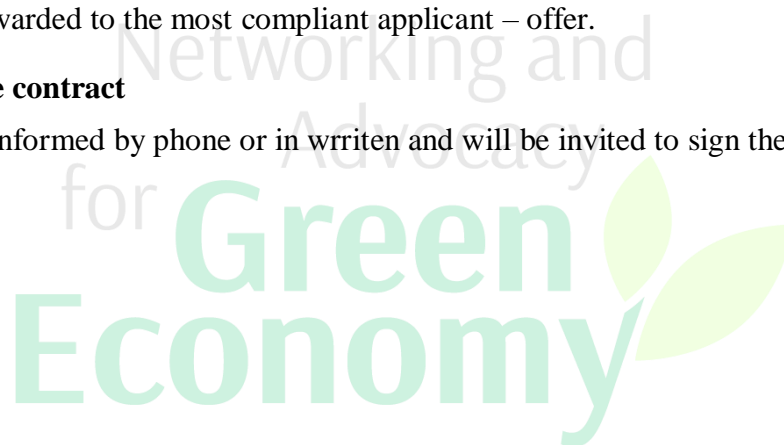
7.3 Award criteria
